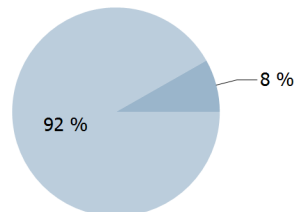

(as % of total exports)

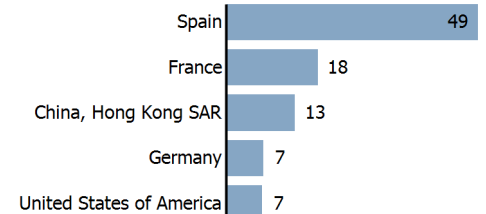

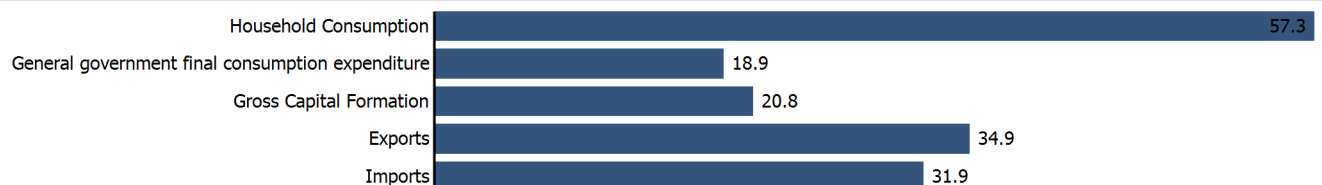
