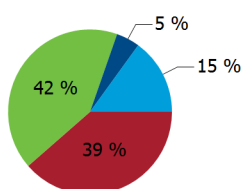

Export structure by product group in 2024

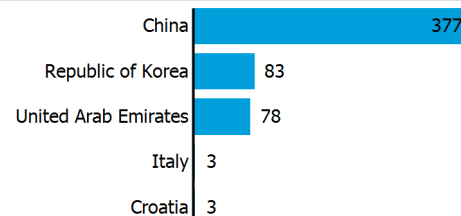

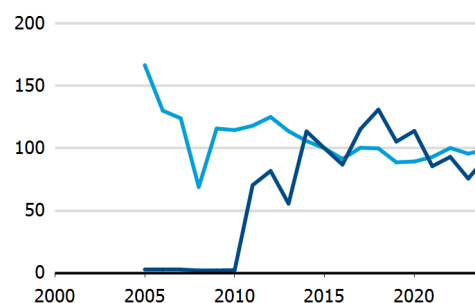

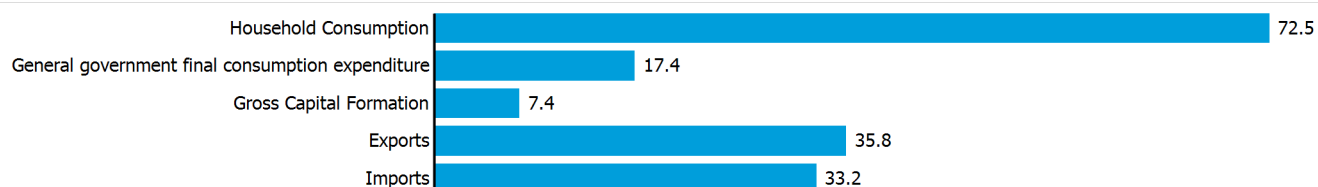

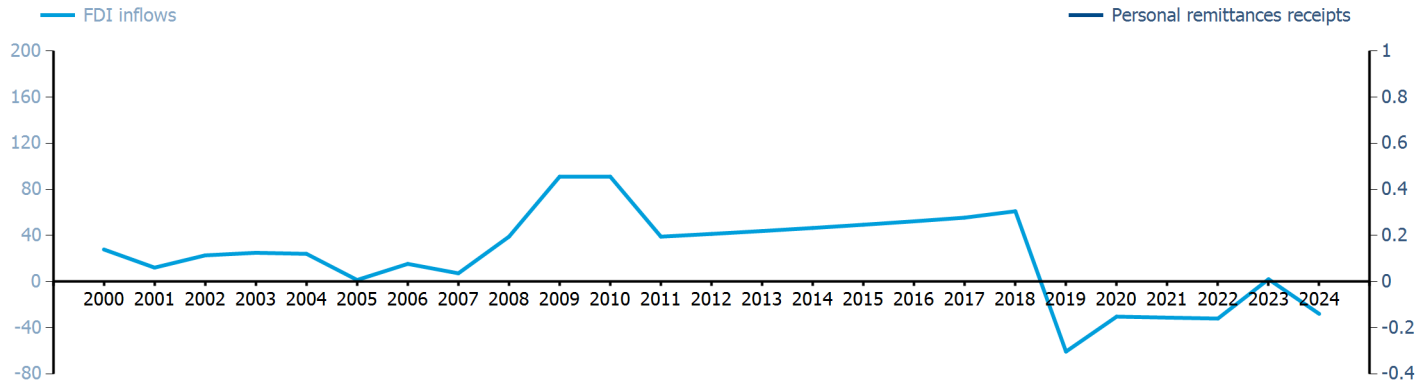

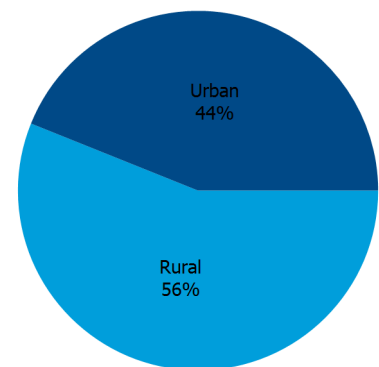
