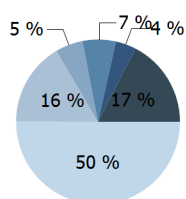

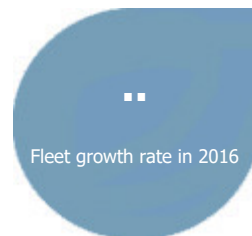

Carrying capacity by type of ship ⁴

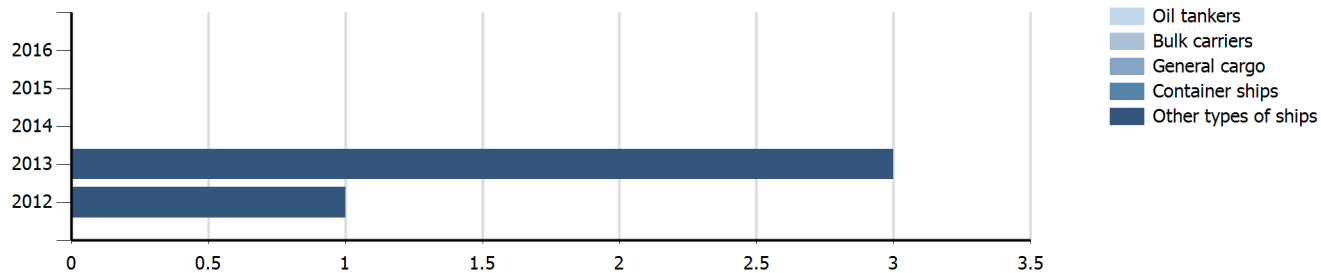
