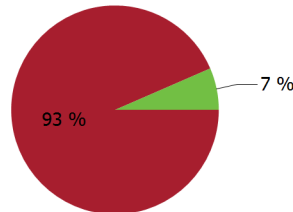
Merchandise exports growth rate in 2023

(as % of total exports)

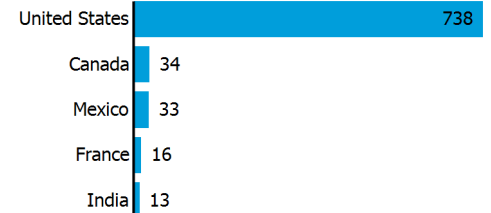

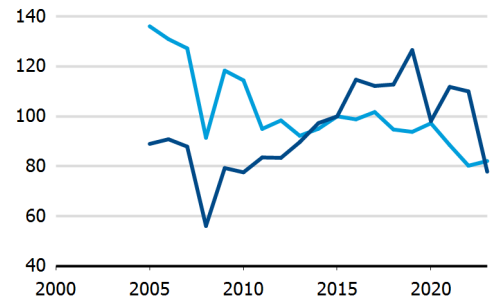

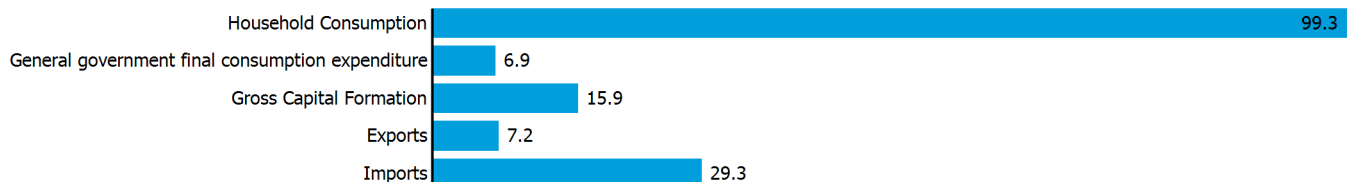

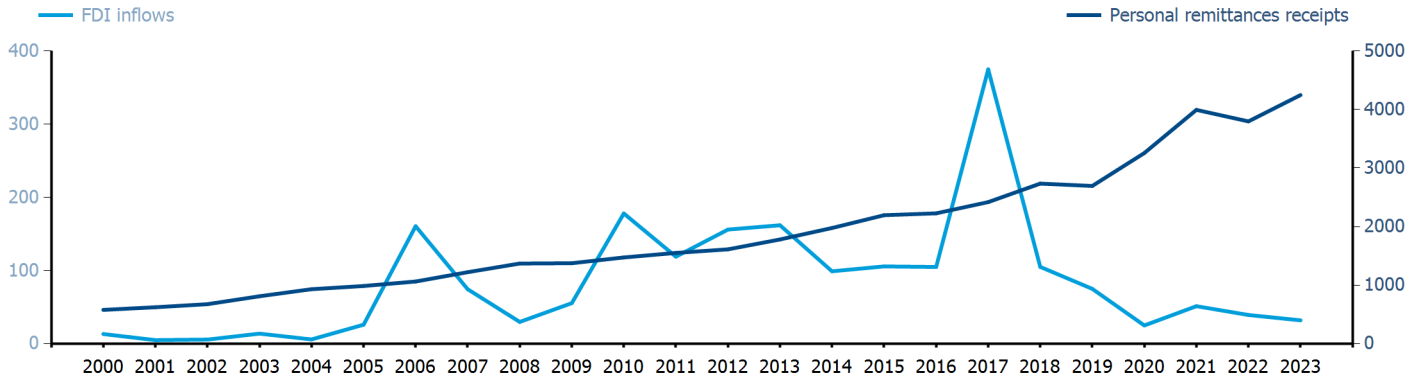

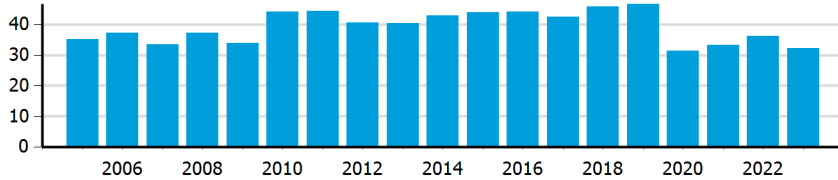

Trade openness²

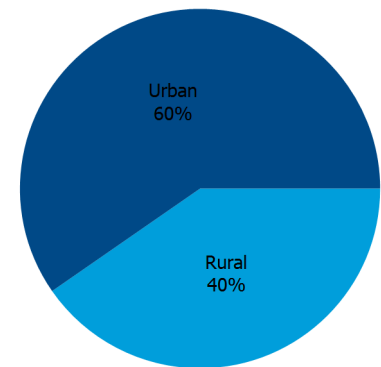
(sum of imports and exports as % of GDP)
