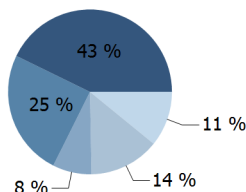

Export structure by product group in 2017

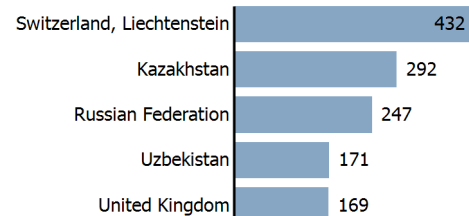

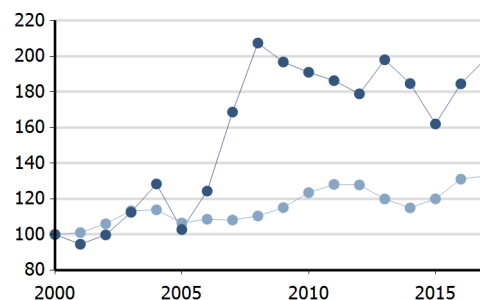

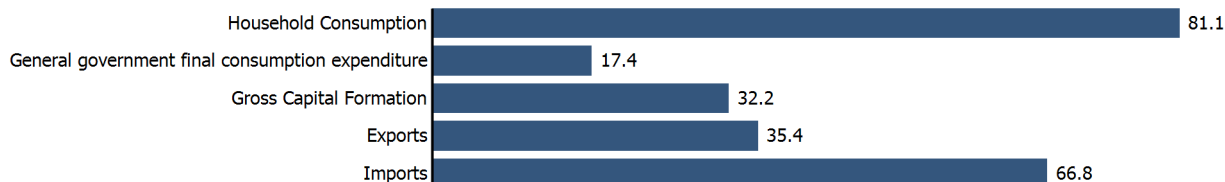

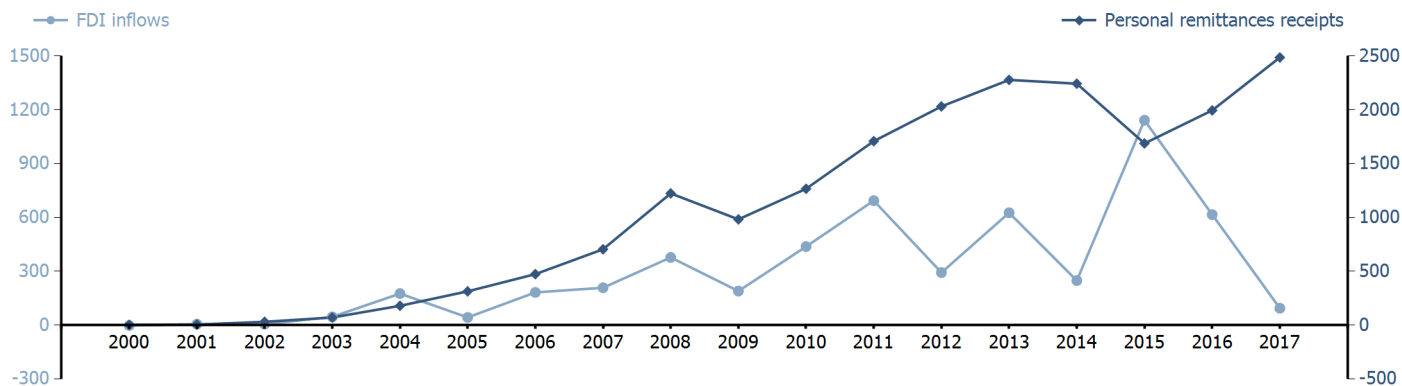

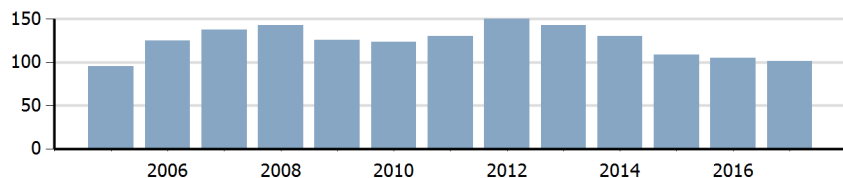

Trade openness ²

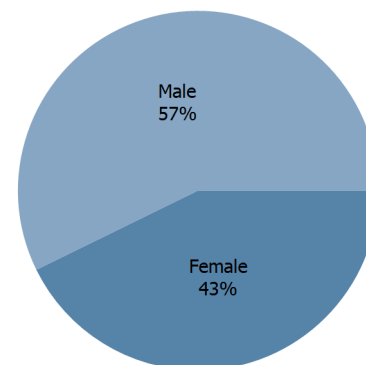
