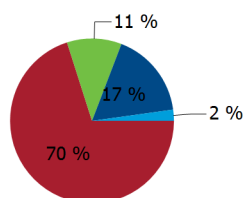

Export structure by product group in 2022

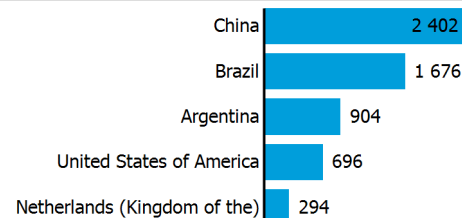

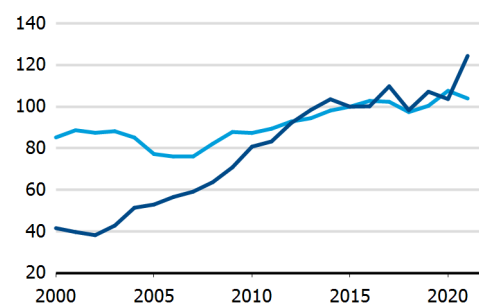

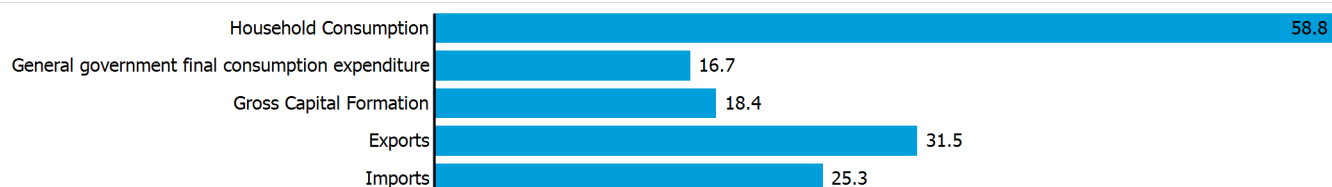

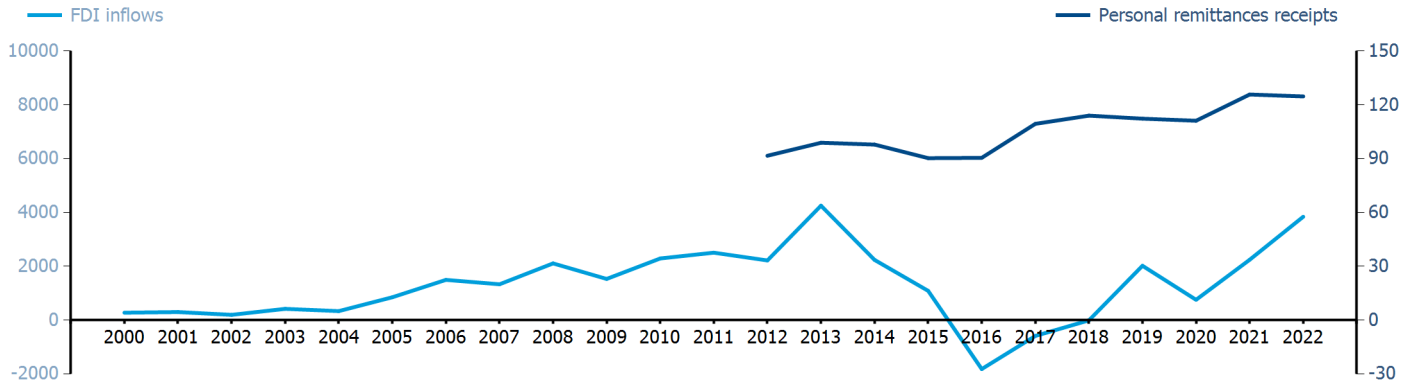

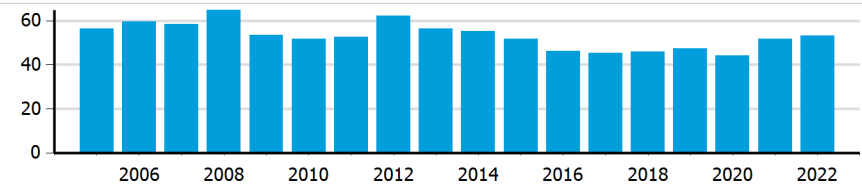

Trade openness²

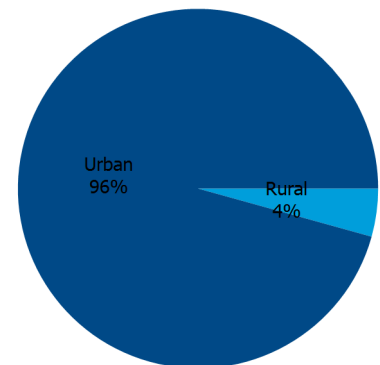
(sum of imports and exports as % of GDP)
