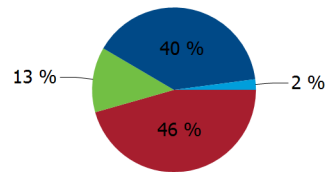

Export structure by product group in 2022

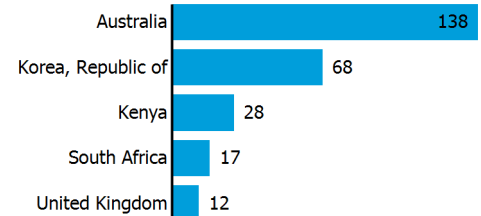

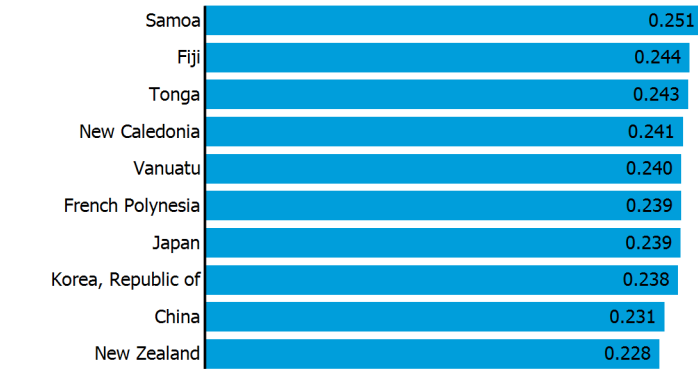

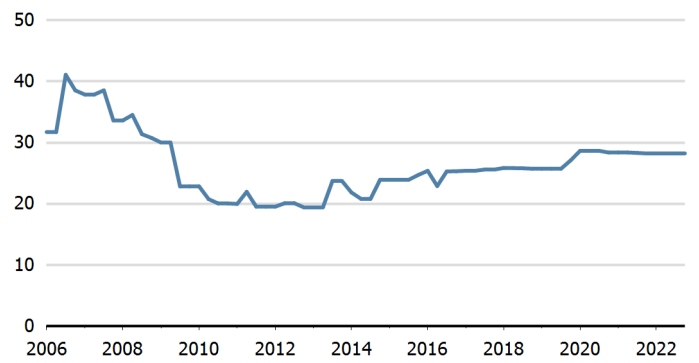
Bilateral connectivity index - Top 10 partners in Q1 2021¹¹

Average Q1 2023=100



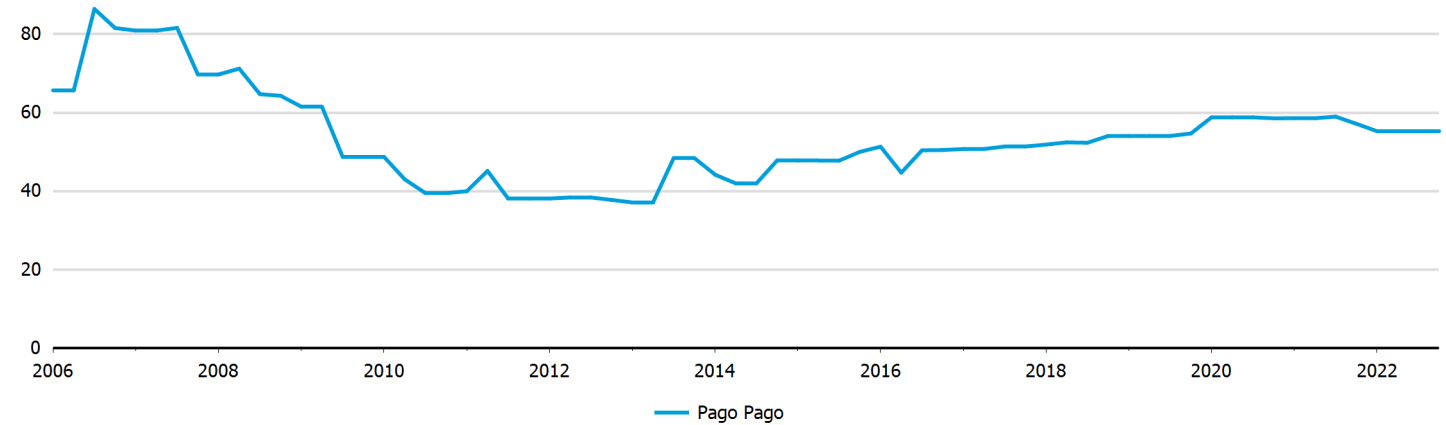
