


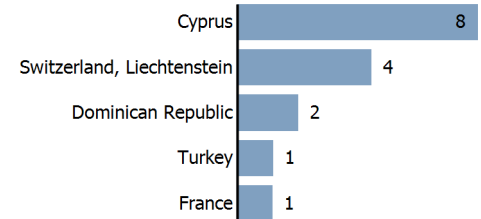
Export structure by product group in 2017

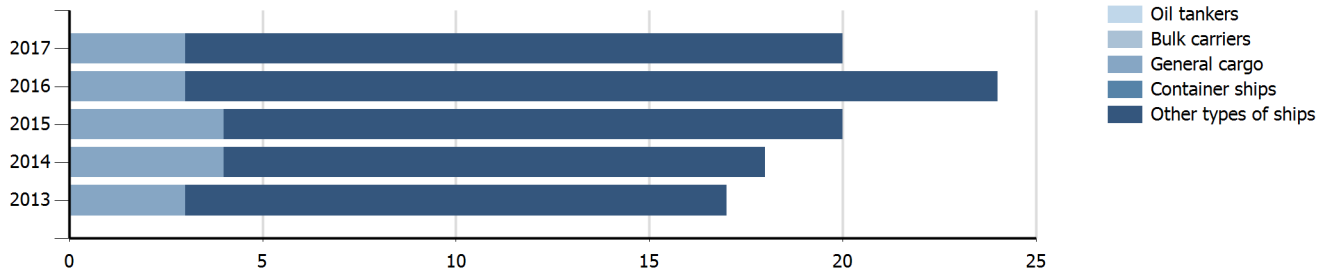

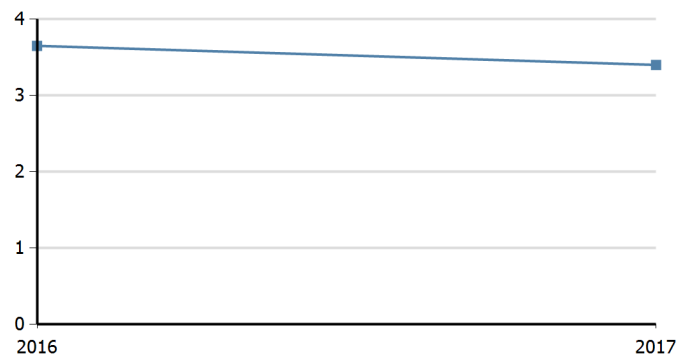
Bilateral connectivity index - Top 10 partners in 2017 ⁸
