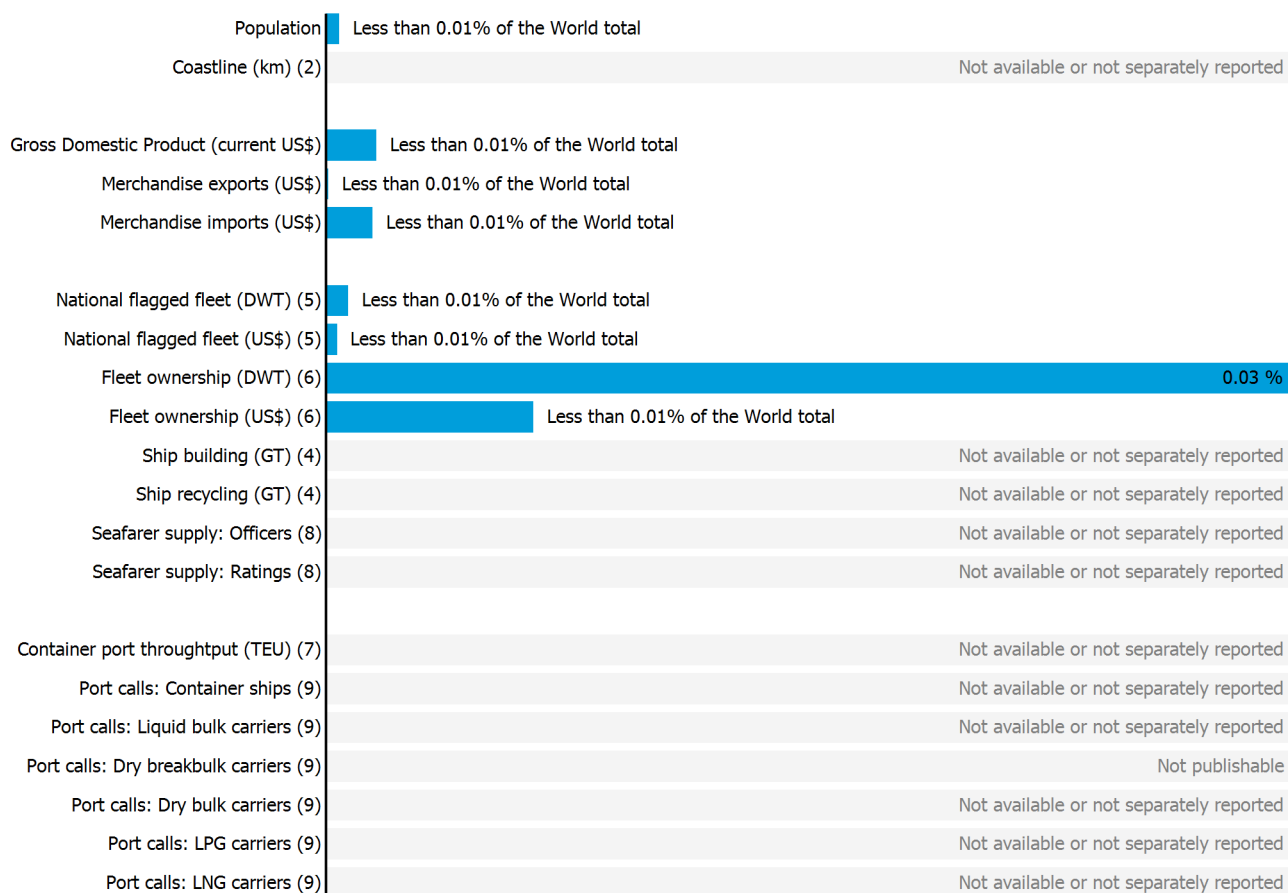

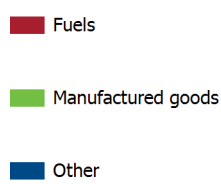

Merchandise exports growth rate in 2022

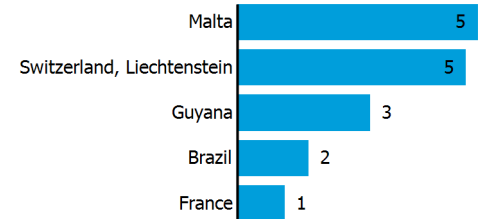
### Export structure by product group in 2022

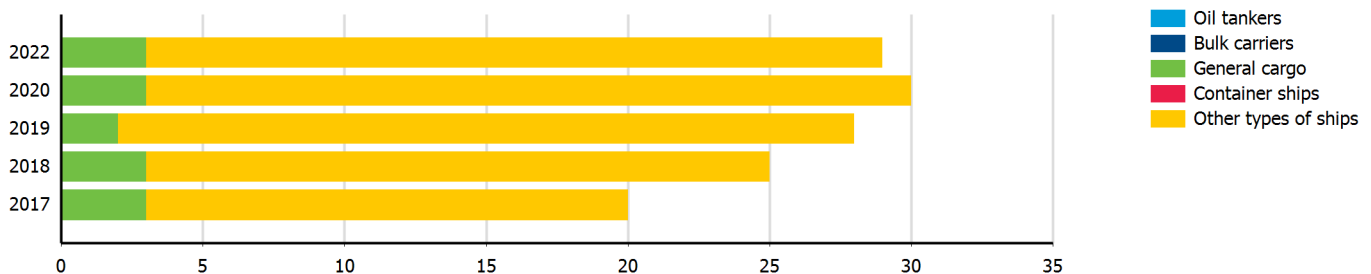

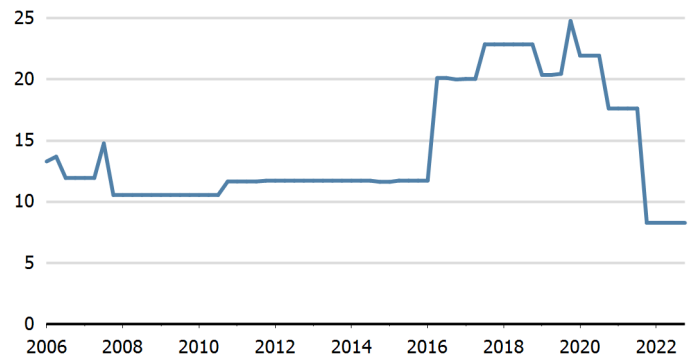

Average Q1 2023=100



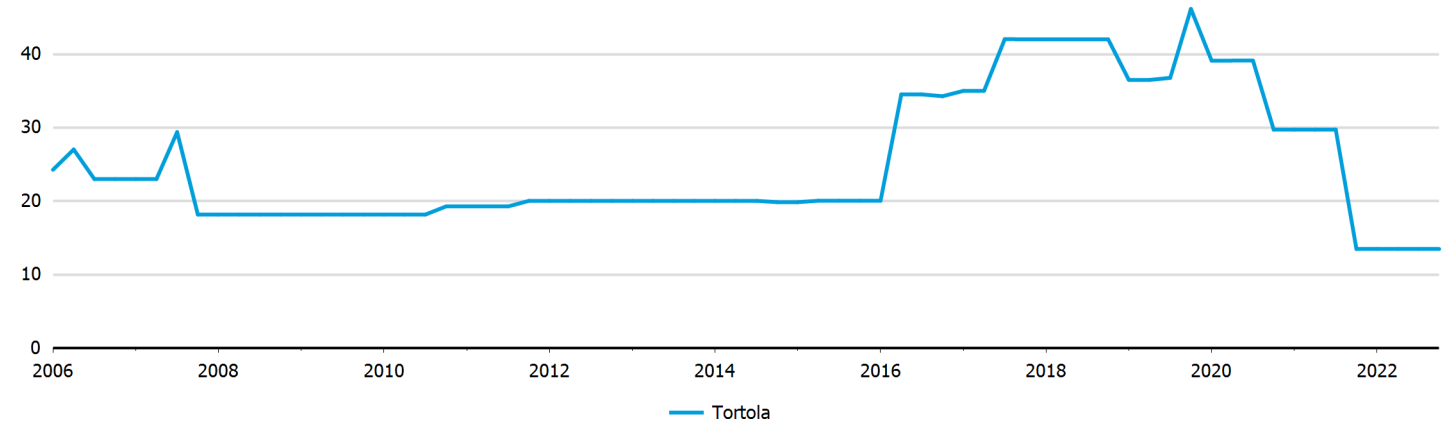
