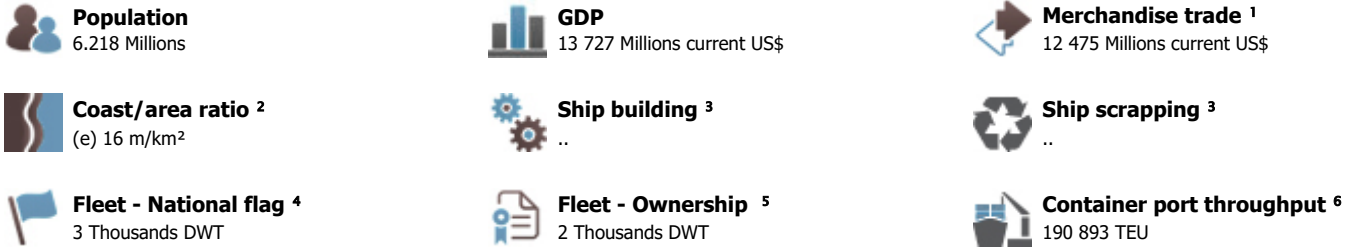
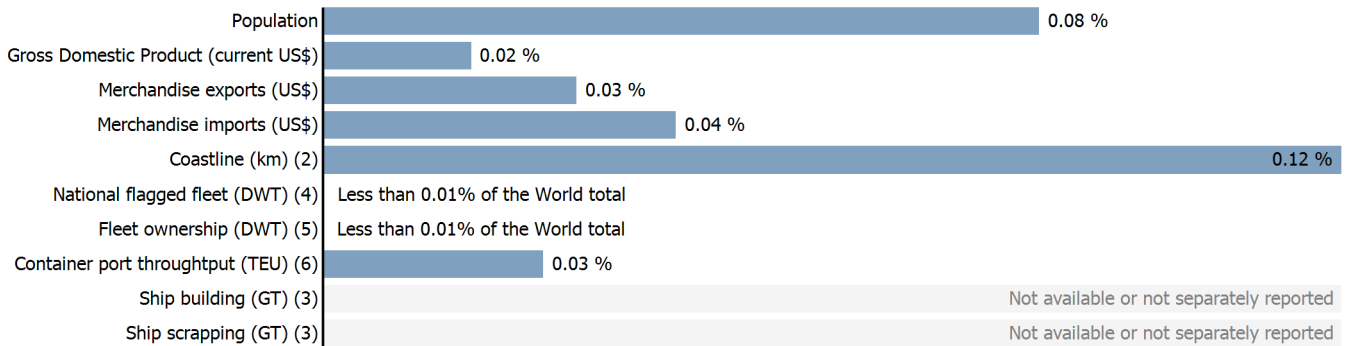

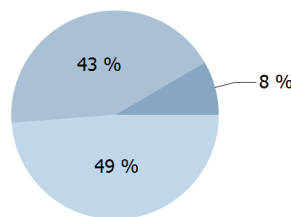

Merchandise exports growth rate in 2017

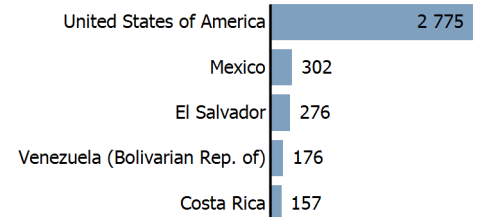
Export structure by product group in 2017

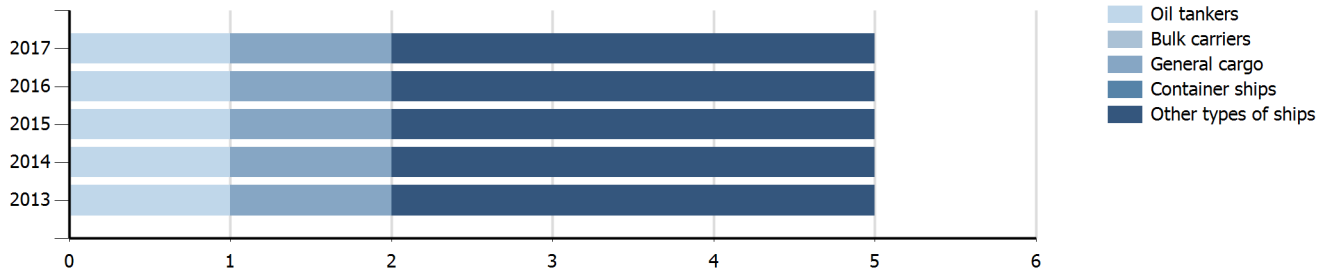

Fleet by type of ship ⁴

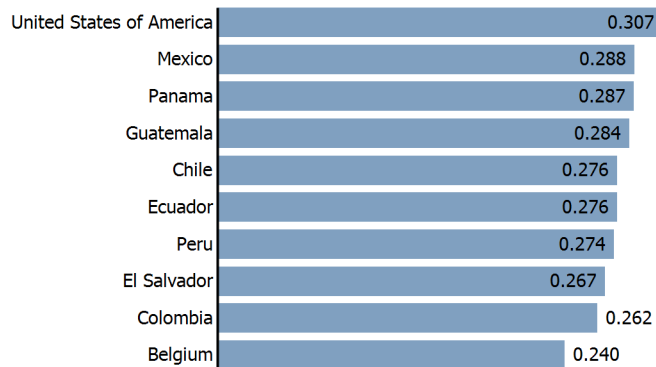

LINER SHIPPING CONNECTIVITY INDEX

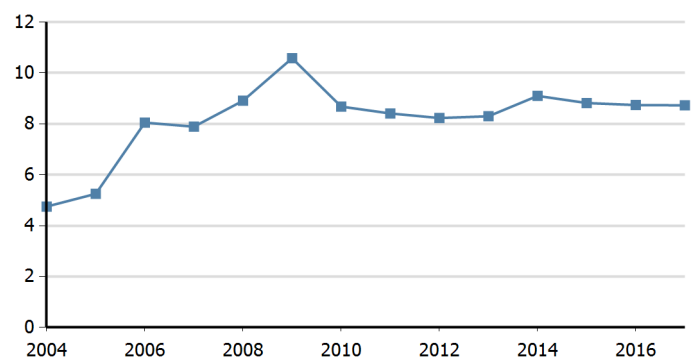
Bilateral connectivity index - Top 10 partners in 2017 ⁸
