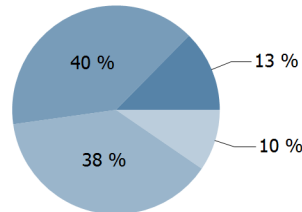

#### Export structure by product group in 2020

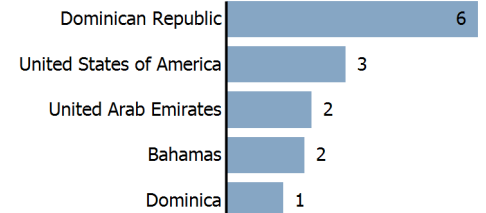

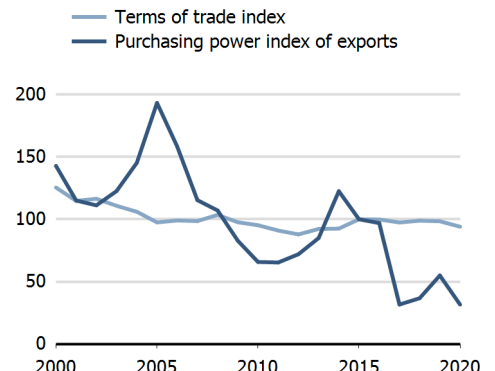

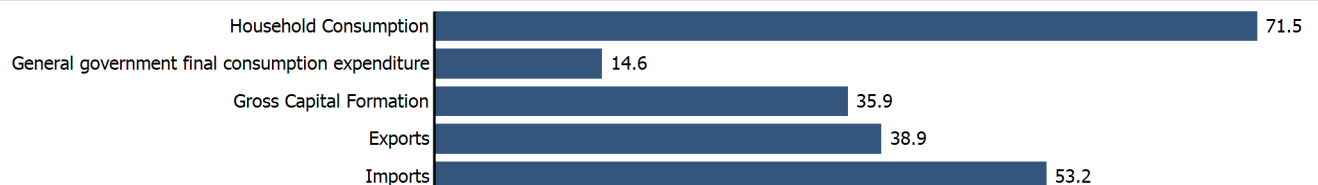

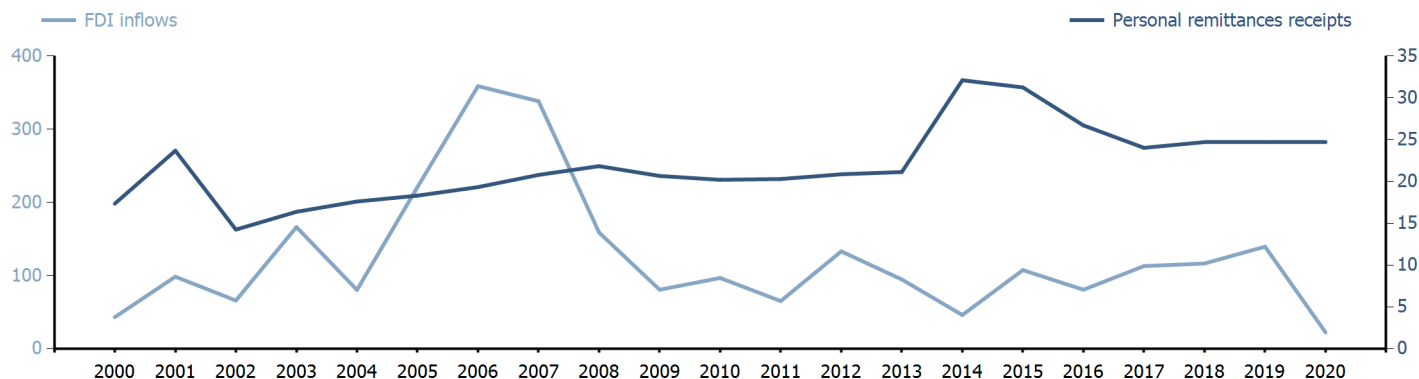

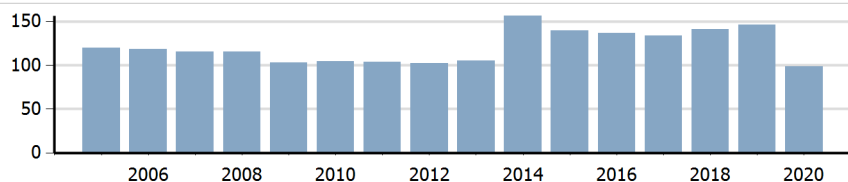
