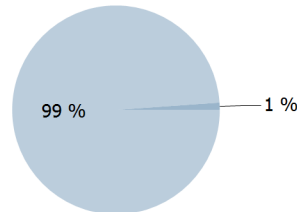
Merchandise exports growth rate in 2020

(as % of total exports)

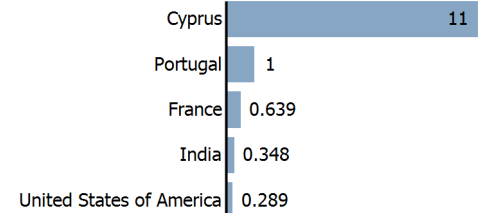

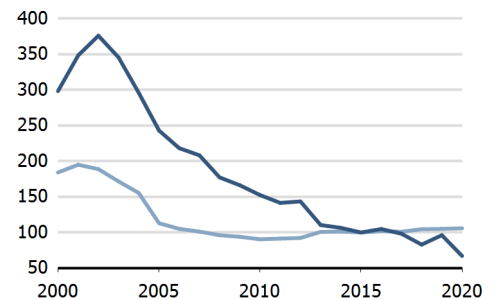

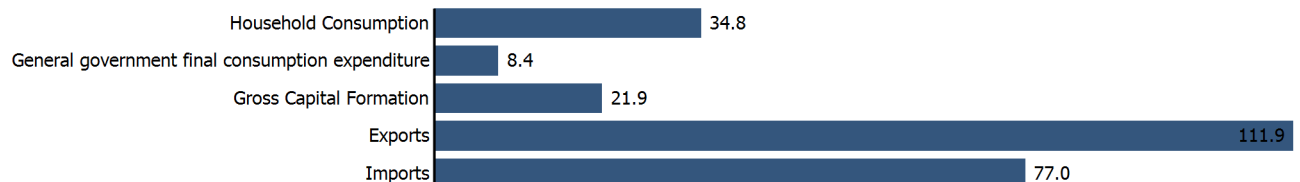

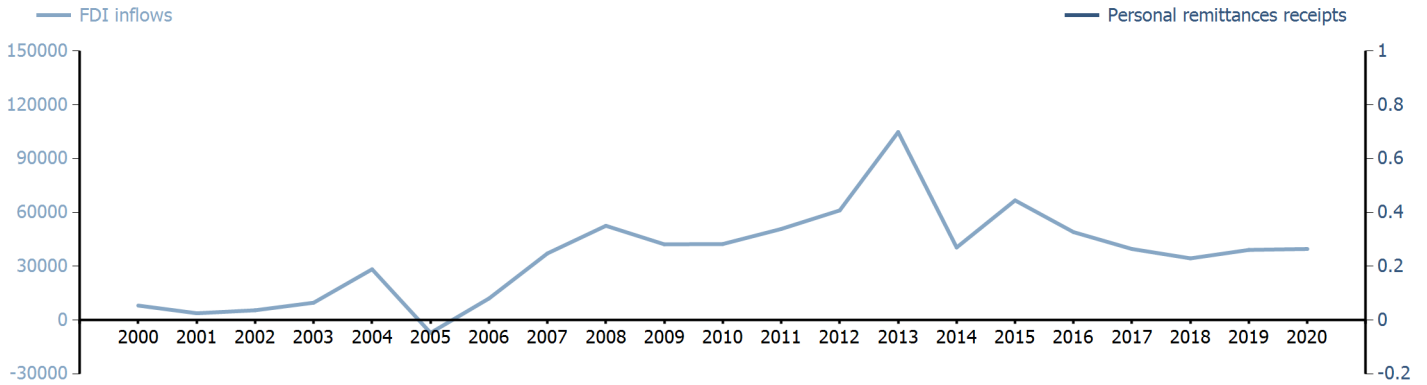
