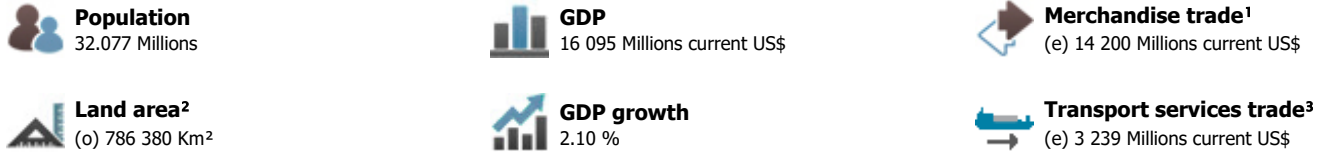

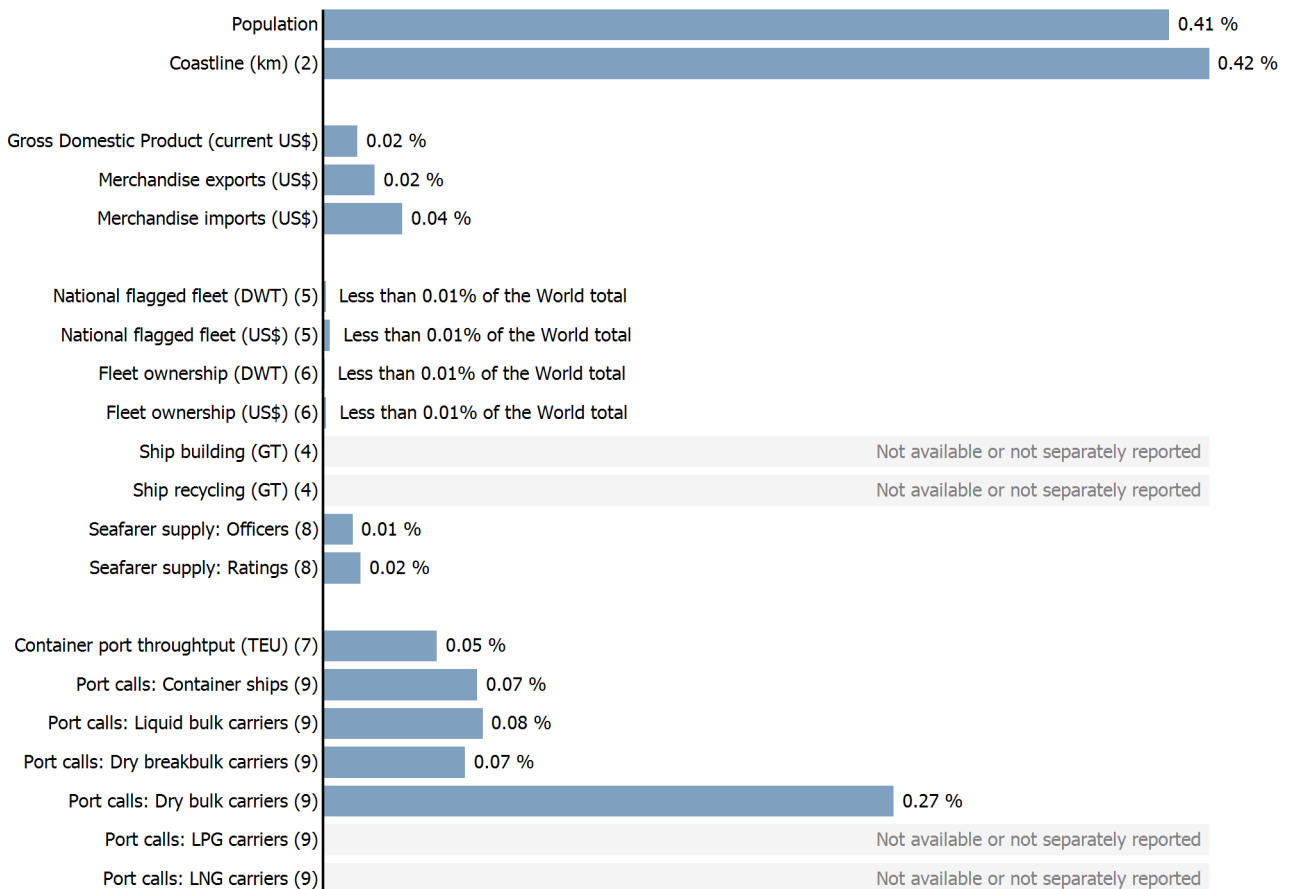

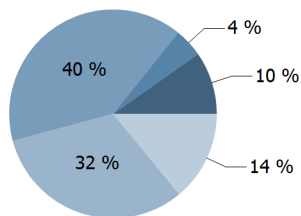

### Export structure by product group in 2021

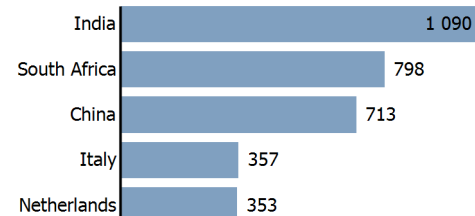
(as % of total exports)

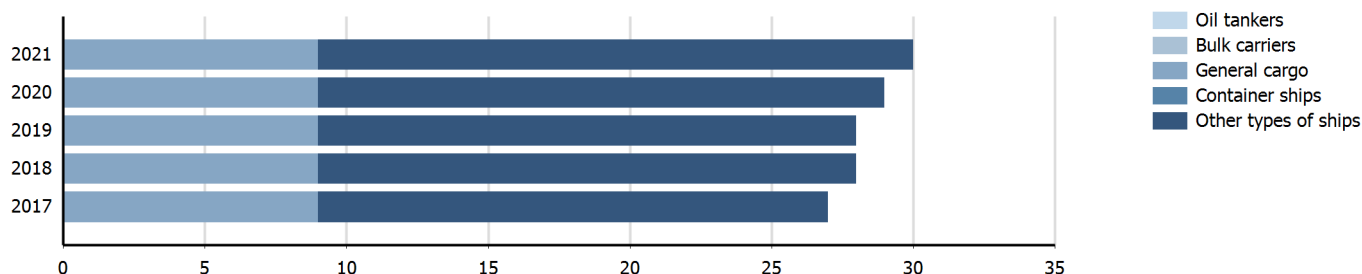

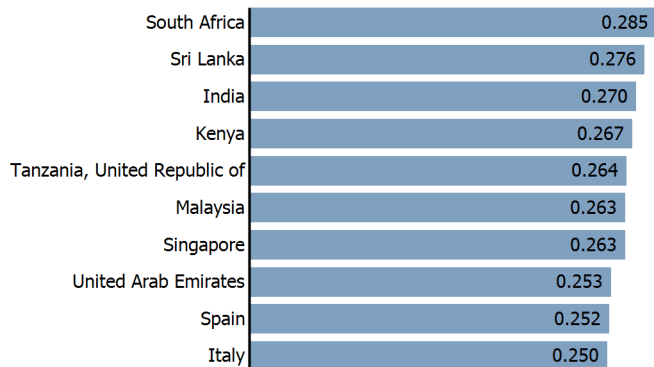

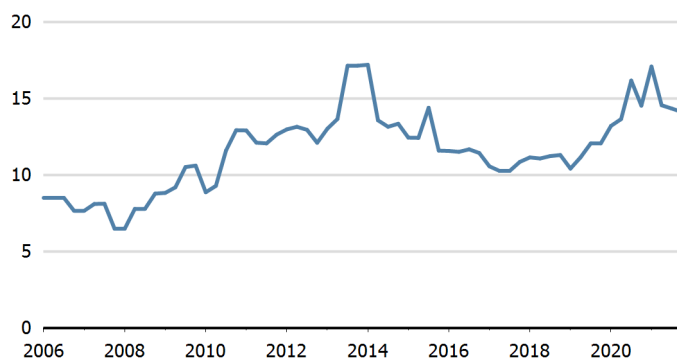
### Bilateral connectivity index - Top 10 partners in Q1 2021<sup>11</sup>

Maximum 2006=100 for China



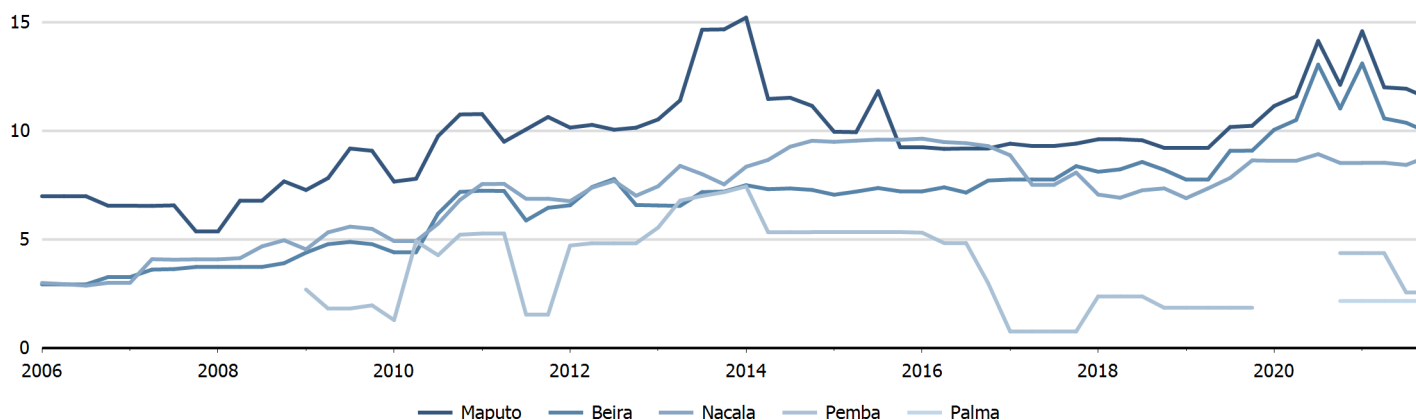
