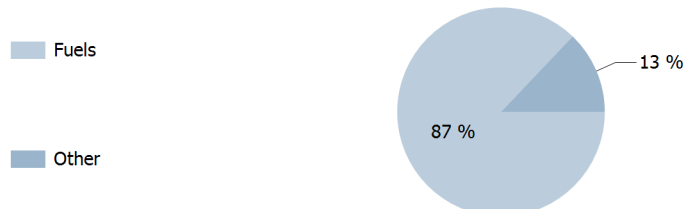

Merchandise exports growth rate in 2020

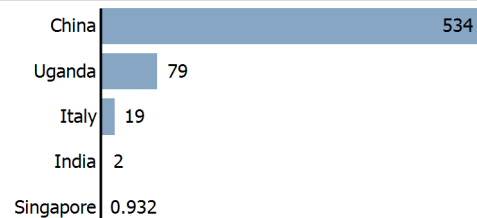
Export structure by product group in 2020

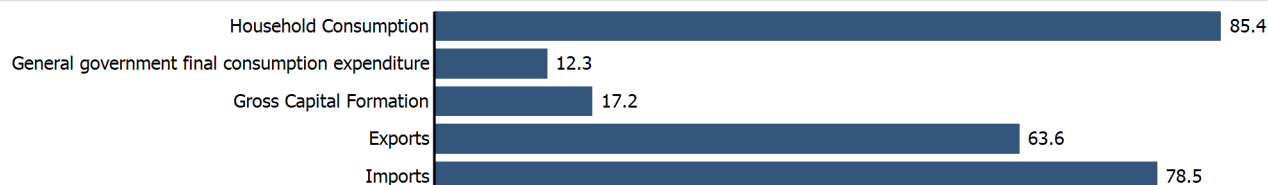

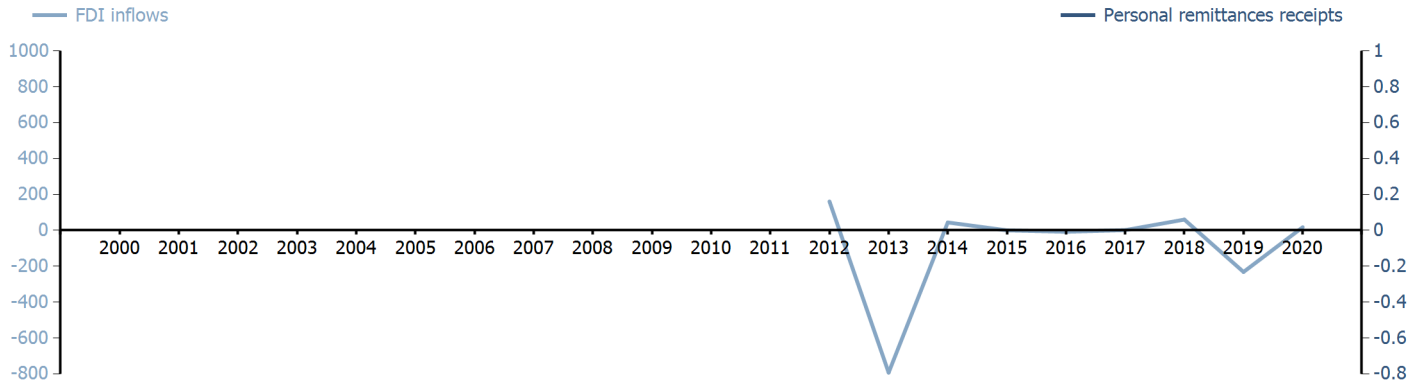

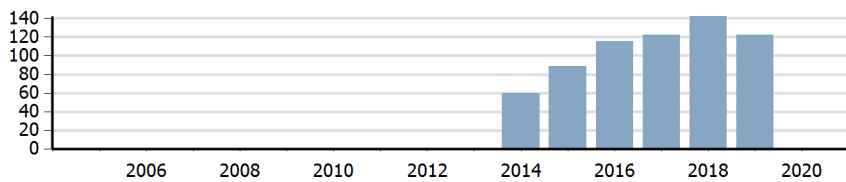
